#### **Building Control Committee Report:**

### **Beaches and Parks Committee Report:**

- The west beach pump is running again. One of the 3-phase fuses for the pump had failed.
   This may have been related to an electrical power line down in the area. The timer control was also readjusted.

# **Lake Level/Water Quality Committee Report:**

- Dye for locating the output of the outfall line has not been obtained yet.
- The board discussed the purpose of spending money using dye to locate the dam water outfall output in addition to all the other unknown factors like the actual volume of water output, the condition of the pipe, etc. that we would still not have any feedback on.
- Requests for quotes to replace the outfall line resulted in a quote for \$7500.

 A MOTION to move forward with replacing the outfall line was made by Matt Miner and was SUPPORTED by Tom Antaya. The motion was approved unanimously.

### **Compliance Committee Report:**

• The board discussed unused disabled boats that have been left on waterfront property for an extended period of time and potential actions that may be taken in the future.

### **Unfinished Business:**

Channel water level and accessibility:

- The board requested new quotes from several companies for increasing the depth of the channel.
- One company declined to put forth a quote after it was determined that the soil composition of the channel is soft material on top for about 1', followed by clay. Vacuum style removal companies would be unable to remove clay.
- One excavation company put forth an initial estimate between 150k-165k.
- Excavation of the channel would require E.G.L.E. approval.
- LGPOA membership approval is required for funding large projects that are not currently line items in the annual budget.
- Channel access and lake level are an ongoing concern of the board.

#### **New Business:**

The Dewitt City Hall Community Room where the LGPOA monthly board meeting was held
this time worked well with availability for scheduling and may potentially be lower cost then
using Dewitt Public School facilities. The board is looking to potentially have meetings held
at City Hall on a regular basis.

# **Guest Comments:**

- Mike Clevenger noted that it would be great if we could have an indicator light on the pumps to know if they are running. This is in regard to the fuse being blown and the pump not running.
- Ken Nye asked if there was a policy for derelict boats. The boards response was that Stu Shaffer would be the person to ask about specific policy questions.
